Florida Board of Dentistry Report

The following FAP members attended the Florida Board of Dentistry (BOD) on February 16, 2018 in Gainesville: Dr. Gary Altschuler, Jim Antoon, Chris Berdy, and Oscar Morejon.

Dr. Charlie Cobb gave a presentation opposing the use of lasers in periodontal therapy. The Board defeated the proposal on the use of lasers by hygienists in periodontal therapy. The only members voting for the proposal were Dr. Fatmi, Ms. Cabanzon, and Mr. Andrade. There was much discussion on this issue. Drs. Gary Altschuler, Jim Antoon, Christian Berdy, Don Ilkka, and Tom Bowers testified in opposition.

Rules discussion included: the BOD Executive Director, Jennifer Wenhold, sharing that the Department of Health is working on a general application for all professions to gather the standardized background information, the BOD approving the language stating if you have a teaching permit you are exempt from the CE requirements (there are still mandatory courses such as CPR required), the BOD also approved language stating a dentist and hygienist can only receive up to 6 hours (as opposed to 7) for pro bono service.

The Florida Academy of Pediatric Dentistry requested the Board create a list of approved programs that comply with the training requirements necessary to get a pediatric conscious sedation

permit. The Board stated the rule language is clear on what needs to be in such training program and it would not be compiling a list.

The BOD executive director reported all anesthesia inspectors have now been trained on tablets to ensure inspections are now more uniform.

The Board passed a motion to amend Rule 64B5-2.0144 to close this loophole and require a credentials check be done when an applicant applies to sit for the Florida Laws and Rules exam in addition to the licensure exam. The Board also directed the BOD executive director that they would like the Department of Health to add language to its bill this Session that would specify a general supplemental dentistry program does not include a specialty program. The Florida Dental Association will be assisting with this effort.

The Florida Hygiene Association actively lobbied the BOD for a rule change to allow dental hygienists to utilize lasers as part of their regular armamentarium, regardless of the outcomes for the patient. Fortunately, extensive lobbying efforts by diligent FAP members and others helped prevent it from passing. Also, efforts to pass a bill in the state legislature for allowing a dental therapist position to be added to the delivery model here in Florida, with what most of us would consider, very minimal educational requirements, have been unrelenting and will likely continue for some time to come.

Despite the many challenges facing our specialty, I, like many of you, feel that this is one of the most exciting and enjoyable times to be practicing periodontics. It seems with every year that goes by, we see new possibilities in our field. These possibilities create the opportunity to expand our scope of practice by acquiring skills and the knowledge base to meet the changing times. We are fortunate to have fine university periodontal residency programs, NOVA and UF, with stellar

residents who graciously share their research findings as part of our annual winter meeting. These programs also provide opportunities to develop relationships with graduate students that can lead to private practice opportunities, for which I have been a personal recipient.

In the coming year, the FAP will continue to strive to provide our membership with excellent continuing educational opportunities at attractive venues, such as this past meeting featuring Dr. Jovanovic, that allows our members to interact and share ideas. Dental implant therapy has been a major component of periodontal practices for over 2 decades. The unique post-graduate training in surgery, regeneration and knowledge of wound healing makes the periodontist best-suited for this discipline. Understanding of physiologic changes that occur after teeth are extracted has changed the way treatment is performed. Combining minimally-invasive techniques with regenerative therapy can counter much of the negative dimensional changes that can lead to esthetic failures.

The use of allogeneic and xenograft biomaterials can negate the need for secondary donor sites and reduce morbidity. This can also result in esthetically-pleasing results that can be maintained for years. Techniques such as the Dermal Apron Technique (DAT) and the Subperiosteal Tunneling Technique (SPTT) eliminate the need to harvest autogenous soft tissue grafts and are proven to augment the hard and soft tissues, which remain stable years after therapy. They also increase the thickness of the supracrestal soft tissues, stabilizing bone levels and masking the shadows caused by abutments and frameworks. Clinical studies validating this techniques, as well as their indications and limitations, will be discussed, with an emphasis on private practice, where these procedures are performed regularly.

The technique of creating screw-retained, provisional restorations, for the periodontist will also be presented. This can enhance case acceptance and grow the referral base for periodontists who perform this step. Methodology and use of appropriate materials will be presented.

Outline:

1. Discuss the physiologic changes that occur following extractions.
2. Present the rationale for augmentation around immediate and delayed implants.
3. Demonstrate two novel techniques, best-suited for periodontists to perform, to enhance lasting, esthetic and healthy outcomes.
4. Present the technique of fabrication screw-retained, provisional restorations in the periodontal office.

Notice of FAP Bylaws Change

According to the Florida Association of Periodontists Bylaws:

CHAPTER VII AMENDMENTS

These Bylaws may be amended by a two-thirds vote of the members present at any meeting provided the proposed amendment shall have been presented in writing at the previous meeting or if copies of the proposed amendment are sent to all members at least sixty, (60) days prior to the meeting. Publishing proposed amendments in the Association Newsletter or on the official website shall also serve as proper notice provided proposed amendments are announced at the previous meeting and published sixty (60) days prior to the meeting. Website publication of proposed amendments shall be continuous for sixty, (60) days prior to the meeting.

Any amendment may be adopted at any meeting by a unanimous vote of the members present.

The following Florida Dental Association Bylaws proposed amendments will be considered at the FAP Business Meeting, August 11, 2018, held in conjunction with the FAP Summer Meeting:

Section 3 Election to Membership

Prospective members must submit an **FAP Membership Application** application to the **Florida Association of Periodontists office**. Secretary, on forms supplied to them by the Secretary, at least one week prior to the meeting:

Election to membership shall not occur until the prospective member attends a meeting. Election may occur at the meeting first attended.

The FAP Secretary shall receive a copy of all membership applications prior to each FAP Executive Council Meeting for review and present applications to the FAP Executive Council for consideration. The FAP Executive Council will vote on each application and acceptance to membership is dependent on a 2/3 majority vote by the FAP Executive Council. If majority vote is not reached, the FAP Executive Council must go into executive session.

The FAP Membership shall announce and recognize new members at the FAP Business Meeting.

A three-fourths affirmative vote of all active members present and voting shall be necessary for election to membership:

A recipient of an invitation **Those accepted** into membership in this Association shall be eligible for the privileges of membership upon payment of initiation fees and dues.

CODA Directs Elimination of “Specialty” Terminology

Dear CODA Community of Interest:

At its February 2, 2018 meeting, the Commission on Dental Accreditation (CODA) took action to remove the word specialty from all CODA documentation, as well as its website, and instead refer to all advanced dental education disciplines as advanced education programs. The Commission concluded that a revision to CODA’s terminology was necessary based upon the following reasons:

- The terminology CODA uses is a carryover of the vocabulary used since 1975, when CODA assumed the policies of the Council on Dental Education and designated postdoctoral dental education programs as specialty programs, or general dentistry programs, based solely on the American Dental Association (ADA) Specialty Recognition Process. This does not reflect the changing environment of dental specialty recognition. In particular, over the past fifteen years, numerous state courts have determined that restricting specialty advertising to the “ADA Recognized Specialties” is restriction of free speech and restriction of trade. The Commission believes that the change in terminology decreases its legal risk in this area.
- The terminology change comports with the scope of the Commission, as recognized by the United States Department of Education (USDE), which does not include specific language to distinguish between “advanced” and “advanced specialty” disciplines within dentistry. The Commission’s scope of recognition with the USDE is: The accreditation of predoctoral dental education programs (leading to the D.D.S. or D.M.D. degree), advanced dental education programs, and allied dental education programs that are fully operational or have attained “Initial Accreditation” status, including programs offered via distance education.
- The Commission is aware that there are misconceptions among many in the communities of interest of the role, if any, that the Commission plays in regards to specialty recognition. The change in terminology clarifies that the Commission accredits education programs, but does not designate which disciplines in dentistry are “specialties.” The Commission’s sole mission is to serve the public and profession by developing and implementing accreditation standards that promote and monitor the continuous quality and improvement of dental education programs.

At its Winter 2018 meeting, the Commission directed CODA staff to identify all necessary CODA materials to be revised, including CODA’s Rules, policies and procedures, Accreditation Standards and supporting documents, and CODA’s website. The Commission also directed staff to submit an Action Plan, to include a high-level schedule of all revisions and a strategy for communicating the implementation of these revisions to CODA’s Communities of Interest. The Commission will consider this Action Plan at its Summer 2018 meeting, to be held August 2–3, 2018. The Commission will continue to keep its communities of interest informed of progress made related to these revisions.

← Message from the AAP President

Last week, the Commission on Dental Accreditation (CODA) released a statement on an action taken during its Feb. 2, 2018 meeting. At this meeting, CODA directed that the word “specialty” be removed from all CODA documentation, as well as its website, and instead refer to all advanced dental education disciplines as advanced education programs.

Many members have asked for further clarification and guidance on what this means for the specialty of periodontics.

CODA accredits education programs but does not designate which disciplines in dentistry are “specialties.” CODA is charged with certifying and maintaining the educational standards for dental education, both pre-doc and post-doc. But CODA does not recognize specialties within dentistry. It is possible for an institution to have a CODA-accredited program in an area of advanced dental education that is not an ADA-recognized specialty discipline. Examples of this would be CODA-accredited programs in orofacial pain and dental anesthesia.

The Commission needs to remain independent and neutral when it comes to the use of the word “specialty” relative to the dental profession and dental education programs under CODA’s accreditation purview. CODA is recognized by the U.S. Department of Education (USDE) as an accrediting body and needs to follow USDE policy so as to retain its recognition by that body. This change by CODA is meant to limit misconceptions about CODA’s role in specialty recognition. CODA’s sole mission is to serve the public and profession by developing and implementing accreditation standards that promote and monitor the continuous quality and improvement of dental education programs.

Specialty recognition is a sensitive area for each of us. Since the first successful lawsuit in Florida 10 years ago regarding dental specialty advertising, specialty recognition has been in flux. The public has a right to clear and unambiguous information as to the training and experience of their health care providers. Your Academy will continue to work tirelessly to maintain the specialty of periodontics on your behalf.
