#### Airway Management Course

The course will provide didactic, video, and case-based hands-on skills labs dealing with medical and airway emergencies possible in the dental and sedation settings.

Participants will review, practice, and demonstrate proficiency in managing emergencies including but not limited to respiratory distress and failure, using bag mask, oral and nasal airways, perilaryngeal devices, as well as intubation and cricothyrotomy. Recognizing and treating emergencies such as cardiac events, stroke, syncope, seizures, allergic reactions and laryngospasm will be reviewed and practiced.

### Saturday, August 14, 2021

Dr. Dennis Tarnow – 5 CEUs – 9am-4pm

#### Morning Lecture: Immediate Extraction Socket Management in the Esthetic Zone.

Immediate placements of implants into extraction sockets is an exciting treatment alternative for our patients. However, there are many potential short and particularly long-term risks which the practitioner must be fully aware of. This presentation will focus on the potential problems and benefits both clinically and biologically when the choice of immediate socket placement is made for single and multiple sites. This will be an evidence-based presentation that will be objective about the best and simplest way to treat these types of cases.



Upon completion of this presentation participants should be able to:

- Identify what type of healing takes place against the implant in immediate socket placement
- Know how to minimize recession with immediate provisionalization
- Know the proper crown contour for immediate provisionals
- Know if the gap distance really matters
- Know if primary closure should be attempted or should it be left open?



## Course Descriptions (cont'd)

- Know if membranes should be utilized?
- Know what type of graft material if any should be utilized?
- Identify what are the potential short and long term risks involved with immediate placement of implants

### Afternoon Lecture: **Molars and Interdisciplinary Management of Aesthetic Problem Cases**

The treatment planning of complex cases requires the highest level of knowledge and skill of the treating team. It is an orchestration of procedures including proper sequencing and timing that makes the difference. An envisionment of the final case before starting is required to know where the goal of treatment will be directed. This, in conjunction with the patient's needs and clinical situation comprise the decision-making process for what is the best treatment for the patient.

Problems facing the team such as:

- Which teeth to save or extract?
- Should implants be placed immediately or in a delayed protocol?
- Should multiple implants be placed in the aesthetic zone?
- When and how to include orthodontics if needed for sight development
- Should pink ceramic be used or should ridge augmentation be performed?
- Should the case be splinted or broken up into separate bridges or individual teeth?
- How to provisionalize the case throughout treatment
- When to immediate load cases versus do a serial extraction case

These concerns will be addressed in this interdisciplinary approach to our most challenging cases.

## AAP Trustee Report

The Board of Trustees met April 30 and May 1, 2021, in-person in Kohler, Wisconsin and via video conference call. The following is a summary of actions taken by the Board.

### Organizational Viability

The Board of Trustees reviewed the 2022 Strategic Plan. Upon review, an amendment was added to Objective 4: Increase awareness of periodontal health. The objective was amended to, "Increase awareness of periodontal health and peri-implant health." Once the objective was amended, the Board of Trustees approved the 2022 Strategic Plan. Highlights of the 2022 Strategic Plan include enhanced digital communication with members, ongoing efforts to influence pre-doctoral periodontal education, the launch of a "think tank" comprised of up-and-coming periodontal scientists, additional outreach activities towards dental hygienists, and amplified engagement between trustees and their districts.

### Leadership

Nominees for the 2021 AAP Awards were presented by the Volunteer Qualifications and Awards Committee with the Board selecting recipients by ballot vote. Trustees also selected finalists for the ADEA William J. Gies Award, a nominee for the ADA Norton M. Ross Award for Excellence in Clinical Research, and a nominee for the ADA Gold Medal Award.

The Board approved proposed appointments to the 2021-2022 In-Service Examination Committee. Other appointments included naming AAP Past President Dr. Donald Clem III as the AAP representative to the ADA National Commission on Recognition of Dental Specialties and Certifying Boards, and Dr. Giorgio Di Vincenzo as the replacement to fill the unexpired District 7 Trustee vacancy for the 2021-2022 year.

Two amendments were made to the Nominations and Elections Policy Manual to more clearly address how vacancies in elected positions should be handled. The revision states, "It is preferred, but not required, that Officer Nominating Committee (ONC) members be past officers and/or Trustees of the Academy. No member of the ONC may run for or serve in an officer position, a position on the BOT, a Director of the American Board of Periodontology, or Director of the AAP Foundation while serving on the ONC, except for Trustees who are completing their terms."

The Board addressed the concerns shared by some Open Forum users regarding Board size. The Board agreed that being fiscally responsible with member dues is part of its fiduciary duty; but acknowledged that decreasing the size of the Board would limit the diversity of location and practice modality, and place a stronger burden on a smaller number of volunteers. The Board confirmed that a finely tuned focus, and commitment to advancing AAP priorities, is the most important consideration rather than the size of the deliberating body.

## AAP Trustee Report (cont'd)

### Education

The AAP's 107<sup>th</sup> Annual Meeting will take place in-person in Miami Beach, from November 4-7, 2021.

Education Consultant, Dr. Nico Geurs' contract was approved for a three-year term, and the next CODA Commissioner in periodontics was selected to serve during the 2023-2026 term.

### Science

Two decisions were made regarding the next Best Evidence Consensus panel. The topic of "biologic mediators" was approved, and Dr. Brian Mealey was selected as Chairperson of the Best Evidence Consensus on biologic mediators committee. Results of the Best Evidence Consensus will be published in the Journal of Periodontology and Clinical Advances in Periodontics in early 2023.

The Board discussed the concept of referral guidelines, at length, and carefully reviewed the 2006 guidelines from a historical perspective. In addition, the Board considered a draft of new guidelines based on the updated disease classification authored by an ad hoc group of members. The Board concurred that the disease classification provides a driver for referral, but was wary about pursuing a prescriptive set of guidelines that may strain collaborative relationships between general dentists and periodontists. The Board ultimately concluded that the initiatives outlined in the 2021 and 2022 Strategic Plans that aim to integrate the staging and grading concept from the updated disease classification into pre-doctoral education, insurance and third-party reimbursement, dental hygiene and general dentist outreach, and consumer awareness will help drive referral to a periodontal specialist.

### Membership

The Board held a robust discussion about the importance of keeping members engaged and ensuring that the Academy is providing the best value to its membership. The Membership Sustainability and Growth Committee was directed to develop a plan outlining membership engagement initiative, in collaboration with staff and outside advisors. The committee will give an update on their progress to the Board of Trustees in August of 2021. The committee was also charged with drafting a new AAP core value that includes verbiage on diversity, equity, and inclusion that will be considered by the Board of Trustees at the August meeting.

# Florida Board of Dentistry Discusses Anesthesia and Lasers

The Florida Board of Dentistry (BOD) met in Orlando on Friday, May 21, at 7:30 a.m. The Florida Dental Association (FDA) was represented by FDA BOD Liaison Dr. **Joe Calderone** and Director of Third-Party Payer and Professional Affairs Casey Stoutamire. Other FDA members also in attendance included Drs. **Dave Boden, Andy Brown, Walt Colon, and Roger Robinson.**

The BOD members present included: Dr. Nick White, chair; Mr. Fabio Andrade (consumer member), vice chair; Drs. Christine Bojaxhi, **Tom McCawley, Claudio Miro, Jose Mellado, Brad Cherry** and **T.J. Tejera**; hygiene members, Ms. Angela Johnson, and Ms. Karyn Hill. There is one consumer position open on the board that the governor has not yet filled.

BOD Executive Director Ms. Jessica Sapp updated the board on legislation affecting the practice of dentistry that passed during the 2021 Legislative Session. She also mentioned that neither the dental therapy legislation nor legislation that would allow the Western Regional Examining Board exam to be accepted for licensure in the state passed this Session.

During the Anesthesia Inspection Report, the anesthesia inspectors requested the Anesthesia Committee look at the amount of epinephrine needed in the dental office. Right now, the rule is an “adequate amount.” This objective standard is causing some confusion and leading to different inspectors requiring dentists to have different amounts upon inspection. Dr. Tejera, chair of the Anesthesia Committee, stated he would hold a meeting sometime over the summer to discuss this issue.

At its November 2020 meeting, the board heard a revised proposal from the Council on Dental Hygiene to allow hygienists to use a laser while performing their remediable tasks, which died on a 4-4 vote. After this vote, the Florida Dental Hygiene Association requested the BOD revisit this rule and hold a workshop on the issue. After its May meeting, the BOD held this rules workshop. After much discussion and testimony, the board adjourned without moving forward with the rule. In addition, the BOD attorney said, on the record, this is not a Federal Trade Commission issue. All BOD members indicated they would revisit the topic if, and when, there is evidence to support the use of lasers by hygienists for bacterial reduction. This also has been the FDA’s position since 2017; when weighing the safety of the public (including cost) with the efficacy, the FDA is opposed to the use of lasers by hygienists for this purpose. Thank you to Drs. Calderone and Brown and Mrs. Angie Brown for testifying. They did a fantastic job presenting the FDA’s position. Dr. Calderone and Mrs. Brown also gave a historical perspective, as they were both BOD members when this issue first arose. Thank you also to the Florida Association of Periodontists (FAP) and its president, **Dr. Walt Colon**, and the Florida Society of Oral and Maxillofacial Surgeons and its president, **Dr. Brett Laggan**, for joining with the FDA to oppose this issue.

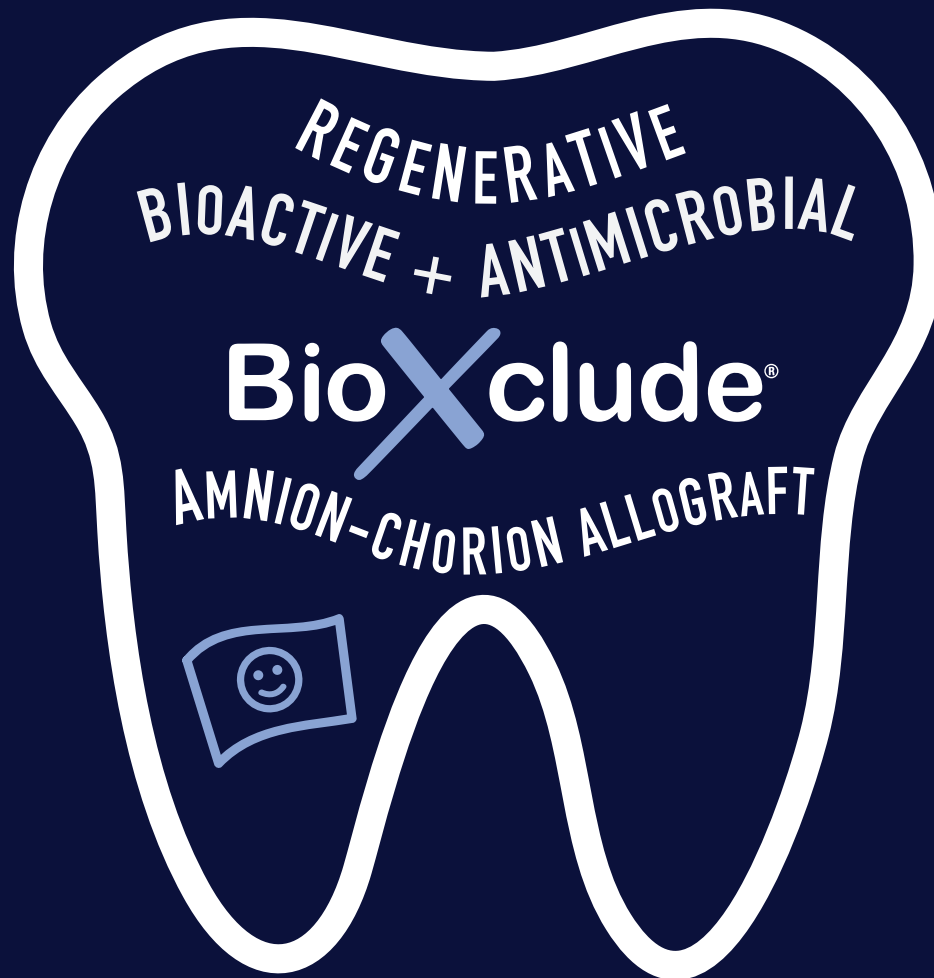

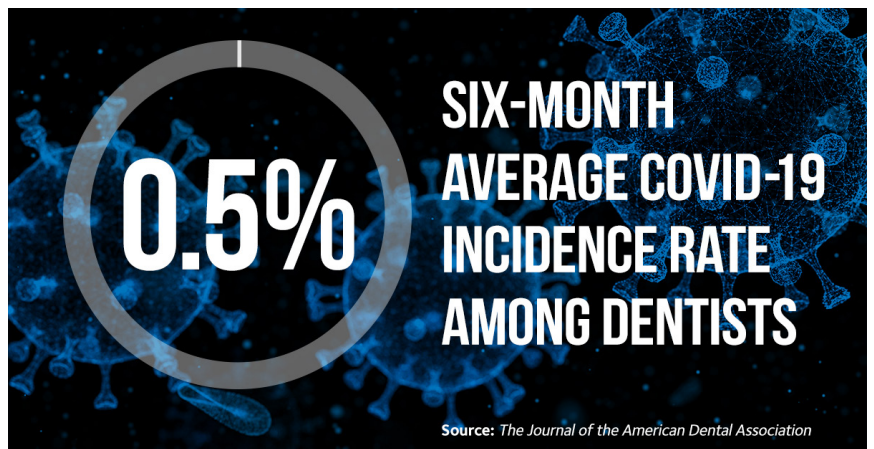
## Covid-19 Incidence Lower Among Dentists Than Other Health Care Workers

A study reported in the Journal of the American Dental Association, found that dentists had experienced a 2.6% cumulative COVID-19 infection rate as of November 2020, with monthly incidence rates ranging from 0.2% to 1.1% and averaging 0.5% over six months. This infection rate is far below that of other health care workers, such as physicians and nurses, ADA News reports.

The ADA study is a continuation of the first large-scale report of U.S. dentists' COVID-19 infection rates and infection control practices published in October 2020 by JADA. The results were weighted according to age and location to approximate all U.S. dentists. Of the initial 2,196 respondents, 1,291 participated in the final survey and 785 participated in all six. Fifty-seven dentists total reported ever receiving a COVID-19 diagnosis. The likely source of COVID-19 was identified via contact tracing by a health agency or clinic in 23 of those cases, with the dental practice identified as the likely infection source in two instances.

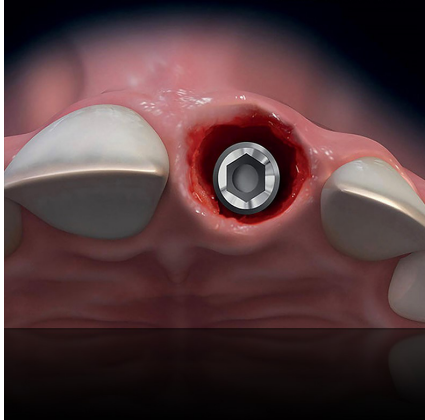
